He will coordinate the inspection and technical work performance of professional and technical staff. He will be responsible for planning, design and other works relating to Viaducts, Bridges, Tunnels, Track, Structures and Buildings including ventilation, ECS, Electrical & Mechanical works and Signal & Telecommunication works etc. He will also oversee the works relating to utility shifting, procurement of track items/fittings, functional control, coordination and monitoring of various Engineering works of the Metro Rail Project.</p> <p>He will manage and monitor technical aspects of Metro Rail Project with ability to do estimation, risk assessment, prepare project milestones, prepare/evolve strategy, prepare/develop technical specifications/design and other parameters for the Metro Rail System.</p>

Should have experience in engineering design, planning, architecture or construction management, preferably in the Mass Transit System or rail projects. Should have experience in handling consultants/contractors in World Bank/ADB/JICA etc. funded projects.</p> <p>Should have a good understanding of the Project Implementation concepts, besides having proven experience in design, planning and implementation.
