Work Experience

- (i) Tenderer should have completed at least one similar single work, i.e. for a minimum value of 35% of the advertised tender value of work in the last three financial years.
 - a. Similar nature of work physically completed within the qualified period i.e. the last three financial years and current financial year will only be considered in evaluating the eligibility criteria.
 - b. The total value of similar nature of works completed during the qualifying period and not the payment received within the qualifying period alone will be considered.
 - c. Certificates from private individual/private limited company/Public Limited Company (Private Sector) for whom such works are executed shall not be accepted. Certificates from Govt./Semi Govt./PSU/Govt. Autonomous Bodies/Public Limited Company (Govt. Sector) of India will only be accepted.

Tenderer must enclose relevant certificates in support of the above eligibility criteria in absence of which, their tender may be liable to be rejected.
