### 1.1 GENERAL

1.1.1 Sealed tenders in prescribed format are invited by The Managing Director, KMRCL from bonafide, reliable, resourceful and experienced contractors/ agencies/Joint Ventures having experience of similar works under Central/State Govt. Departments/organizations for the work as mentioned below:

01. Name of the work : Painting of Viaduct Structure including the Underside of the Elevated Stations Buildings and Viaduct Railing for the proposed Kolkata East West Metro Rail Project
02. Approximate cost of work : Rs. 4,00,00,000/- (Rupees Four Crore only)
03. Earnest Money : Rs. 4,00,000/- (Rupees Four Lakh only)
04. Completion period of the work : 3 (Three) months **from date of issue of LOA.**

##### Work Experience

Satisfactory completion of similar type of work during last three financial years including current financial year of value:

a. not less than 80% of estimated amount put to tender for one job

OR

b. not less than 50% of estimated amount put to tender for each of two jobs

OR

c. not less than 40% of estimated amount put to tender for each of three jobs

**(Similar work will be Anti Carbonation Painting work in Concrete Bridge/ Viaduct in Road OR Metro systems with authorization for application from the approved paint manufacturers)**

Tenderer must enclose relevant certificates in support of the above eligibility criteria in absence of which, their tender may be liable to be rejected.
