Departments/Organisations/Autonomous Body for the work as mentioned below

01. Name of the work : Construction of brick wall along periphery of concourse level for safety purpose for all 6(six) elevated stations.
02. Estimated amount put to tender : Rs. 9,91,659 /- (Rupees nine lakhs ninety one thousand six hundred fifty nine only)
03. Completion time : 3(Three) months.
04. Cost of Tender document : Rs.1,000/- (Rupees one thousand only) (non refundable) to be submitted in the form of Bank Drafft/Pay Order payable at Kolkata from any Nationalised Bank in favour of 'Kolkata Metro Rail Corporation Ltd'.
05. Earnest Money : Rs.19,850/-(Rupees nineteen thousand eight hundred fifty only) in the form of Bank Drafft/Pay Order payable at Kolkata from any nationalised Bank/scheduled commercial bank in favour of Kolkata Metro Rail Corporation Ltd. to cover @ 2% of estimated amount put to tender.
06. Retention Money(10% of tendered amount) : Initial Earnest Money will be converted to Retention Money. Balance amount of Retention Money will be realised from progressive R/A bills @10% of each R/A bill till total retention money reaches 10% of total Tendered Amount.

07. Eligibility criteria :

- i) Experience of satisfactory completion of similar type of works under Central/State Govt. Department/Kolkata Municipal Corporation/KMDA during the last seven years ending 31st March 2014 including current financial year (Client's certificate shall be submitted) of value:
 - a. not less than 80% of estimated amount put to tender for one job
or
 - b. not less than 50% of estimated amount put to tender for each of two jobs
or
 - c. not less than 40% of estimated amount put to tender for each of three jobs

(N.B) – Similar work means brick work including Building Work

- ii) Average annual financial turnover for the tenderer shall not be less than 14.87 Lakh for the last three financial years ending 31st March 2014.
 - iii) All materials are to be procured and supplied at site of work by the tenderer/firm at his/their own cost from approved /reputed firm/dealer/manufacturer.
08. The tenderer shall have to mobilize all men, machinery and field-testing machinery equipped with apparatus and instruments within 7 days from the date of Work Order.
09. The offer shall remain valid for 90 (ninety days) days from the date of opening of the Tender.
10. Conditional tender will not be acceptable.
11. The contractor/agency will have to produce valid latest IT Return, PAN, VAT, Profession Tax certificate with the application along with other copies of relevant documents [copies to be attached with application and original to be produced for verification] not limited to:
- (i) Attested copy of Power of Attorney (in favour of Authorised Signatory of the Tenderer
 - (ii) Power of Attorney from each member in case of group.
 - (iii) Memorandum of Understanding (MOU) for the consortium of joint venture.
 - (iv) Document regarding total value of work done in last five years as mentioned above in Sl. No. 6(i)
12. Statutory deductions towards ST, IT as well as construction workers' welfare cess @ 1% will be deducted from each bill.
